TIPS FOR USE

Foot baths outside the milking parlor at least once a week; in cases of high morbidity, wash daily. In the special footbath with the compulsory passage of the animals, prepare a product solution of 3-10% in water. Do not use for animals with open podal lesions.

The product should be used in an open and ventilated environment.

We recommend for use, utilisation, storage, etc. to follow the instructions on the safety data sheet.

PRECAUTIONS FOR USE

Protect the product against frost, store away from heat sources, keep containers tightly closed.
